## What is the pageant?

## Who may enter?

Any member in good standing in her Bethel who enjoys meeting the public, is knowledgeable of our Order and capable of representing Job's Daughters with fun-loving dignity, grace and charm. The contestant may not be a Past Miss Kansas Job's Daughter or the current Grand Bethel Honored Queen.

## Requirements

Junior Miss Kansas Job's Daughter Contestants:

- \* A member in good standing in her Bethel who is 13 to 15 years of age
- \* Completion of Registration Form and a \$30 entry fee (or \$40 late entry)
- \* Loves Job's Daughters!

Miss Kansas Job's Daughter Contestants:

- \* A member in good standing in her Bethel who is 16 years of age and cannot have reached the age of 20 by June 11 (day of the pageant)
- \* Completion of Registration Form and a \$30 entry fee (or \$40 late entry)
- \* Expected to attend Supreme Session in Colorado Springs, Colorado August 2-7, 2010 to represent Kansas in the Miss International Job's Daughter Pageant (all expenses for Supreme Session are daughter's responsibility)
- \* Loves Job's Daughters!

The entry fee is to be paid by the contestant or her Bethel. Checks should be payable to **Grand Session 2010**. There will be a pageant luncheon and the fee must be paid at the time of registration for Grand Session with her Bethel.

Registration Form and entry fee must be **Certified Mail – Return Receipt Requested**.

ENTRIES MUST BE POSTMARKED NO LATER THAN MARCH 1, 2010 and include the \$30 entry fee. **Late entries** must be postmarked NO LATER than April 1, 2010 and must include a \$10 late charge for a total entry fee of \$40. An entry postmarked after April 1, 2010 will NOT be accepted.

Further information will be sent to each contestant immediately following the deadlines, not as each entry is received.
